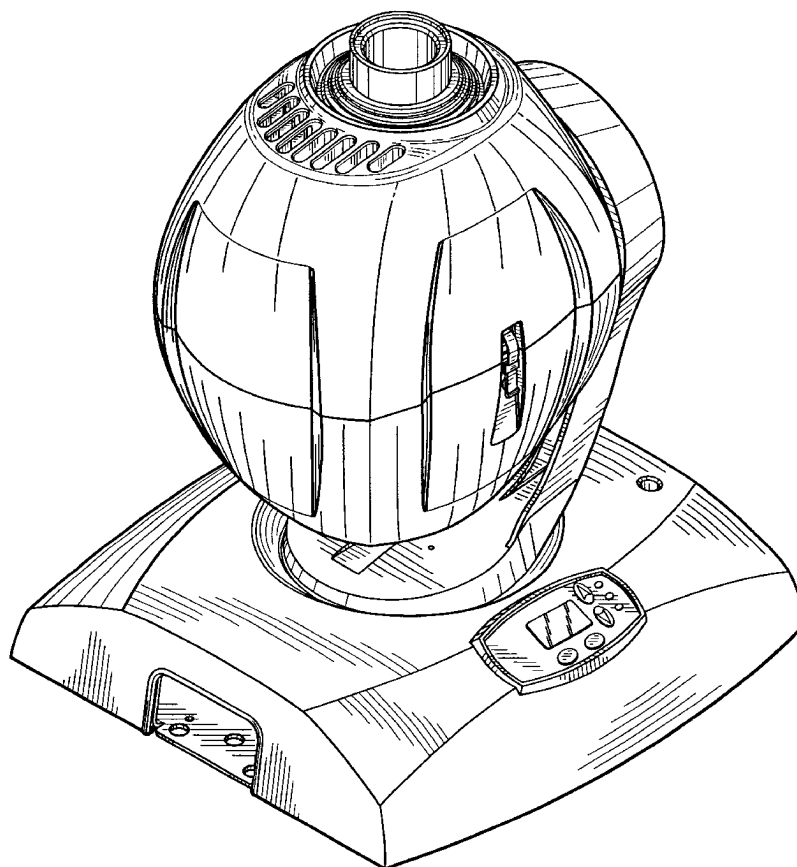
(57) **CLAIM**

The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a light fixture showing our new design; FIG. 2 is a left side elevational view of the light fixture illustrated in FIG. 1; FIG. 3 is a front elevational view of the light fixture illustrated in FIGS. 1-2; FIG. 4 is a rear elevational view of the light fixture illustrated in FIGS. 1-3; FIG. 5 is a top plan view of the light fixture illustrated in FIGS. 1-4; and, FIG. 6 is a perspective view of the light fixture illustrated in FIGS. 1-5.

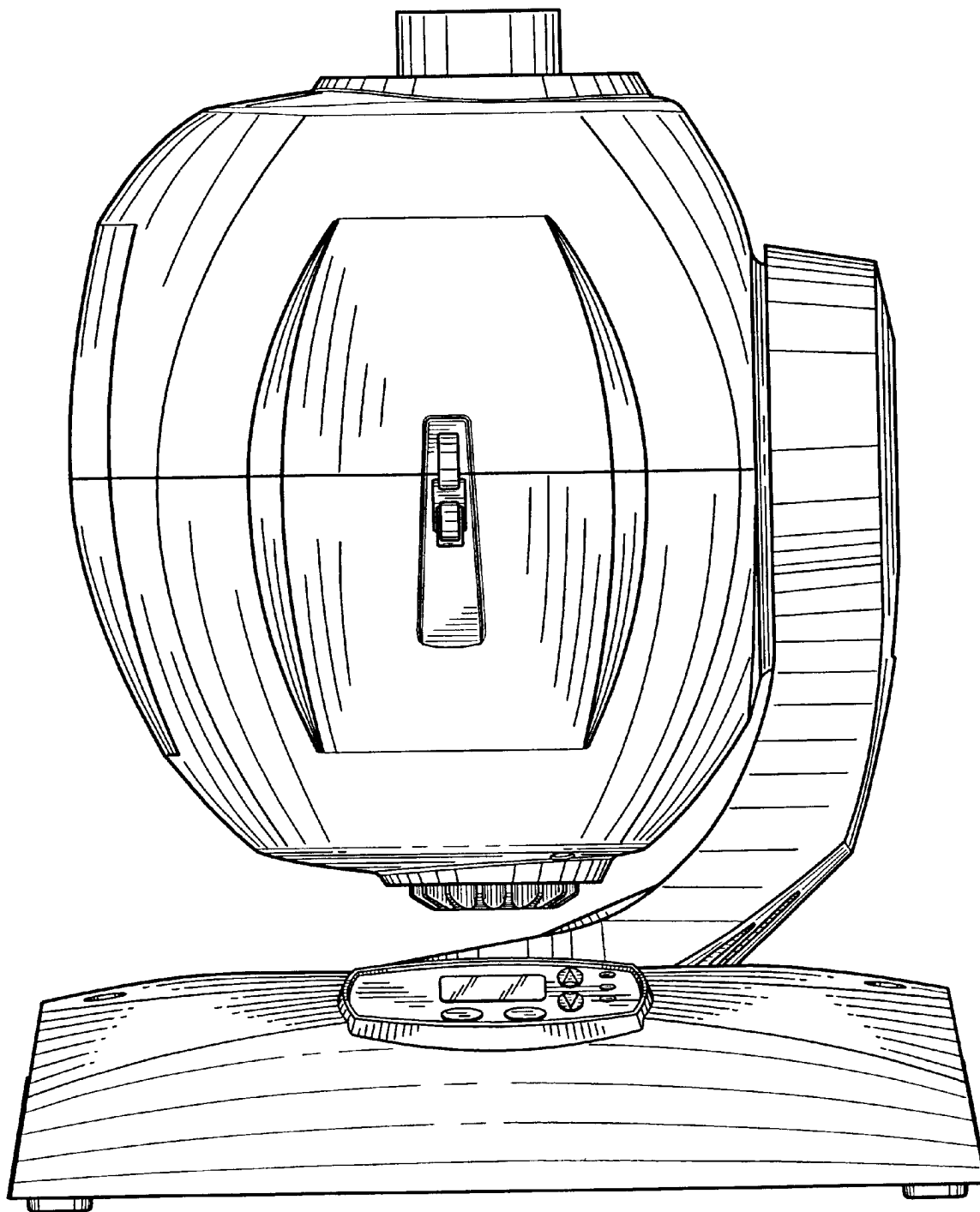

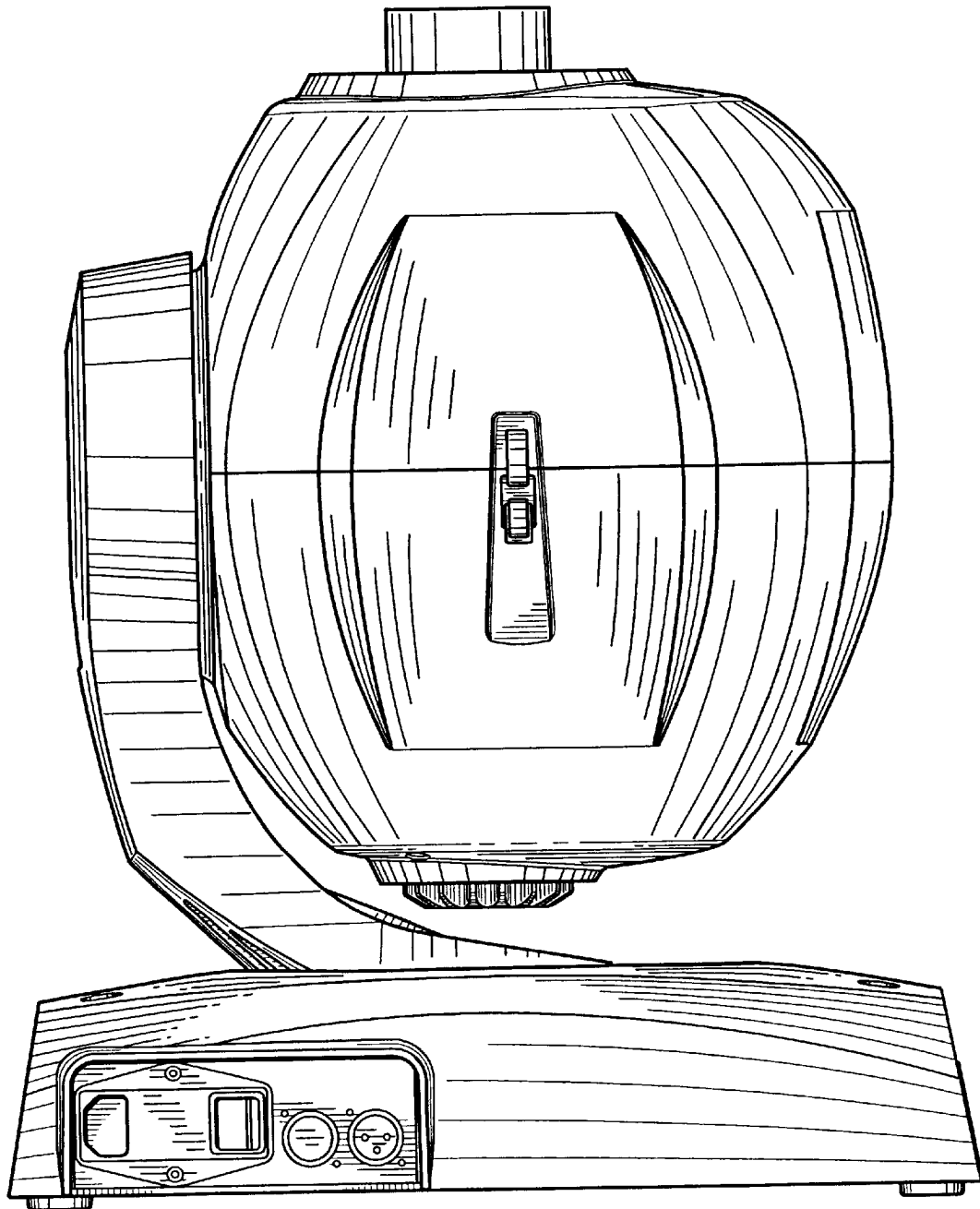

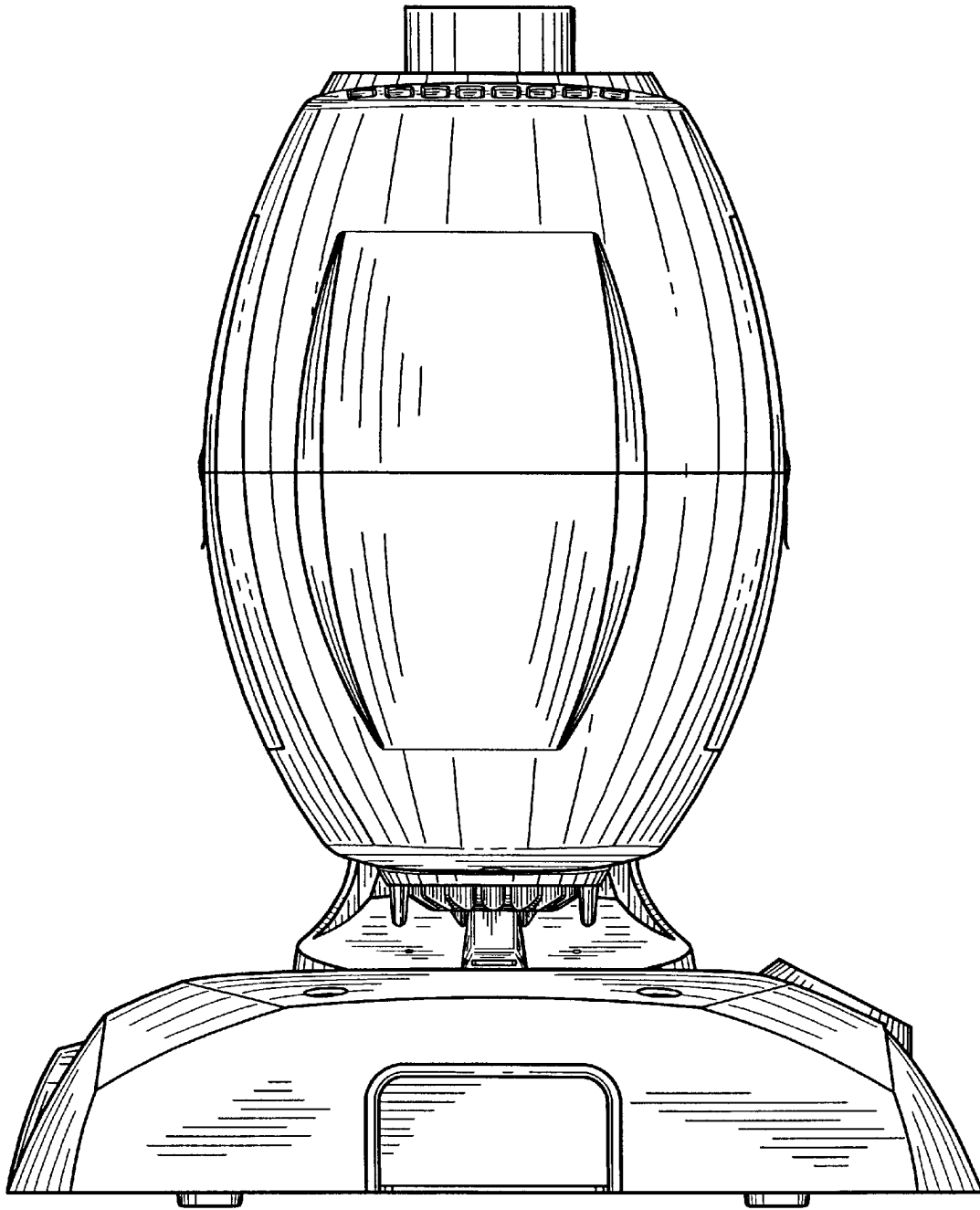

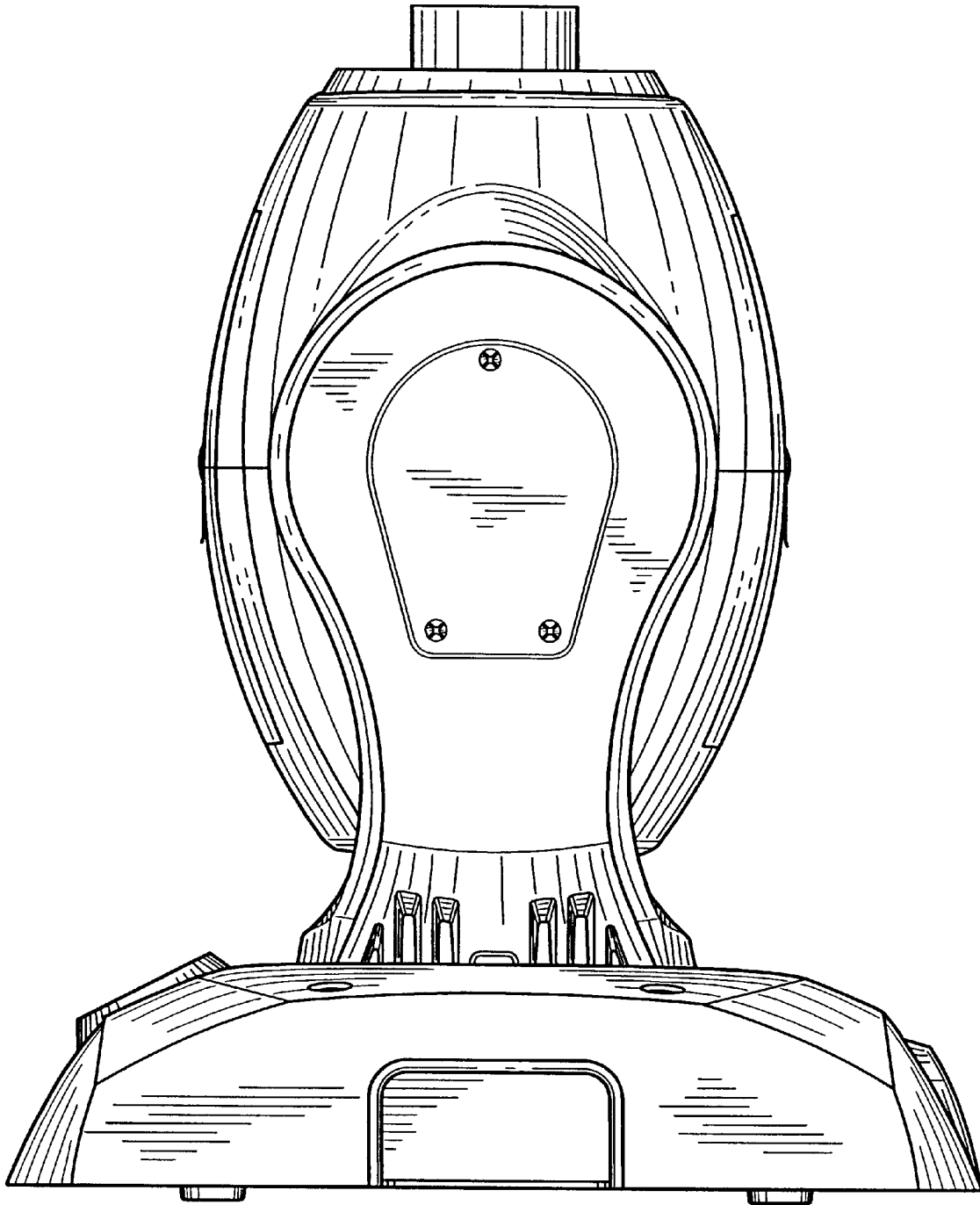

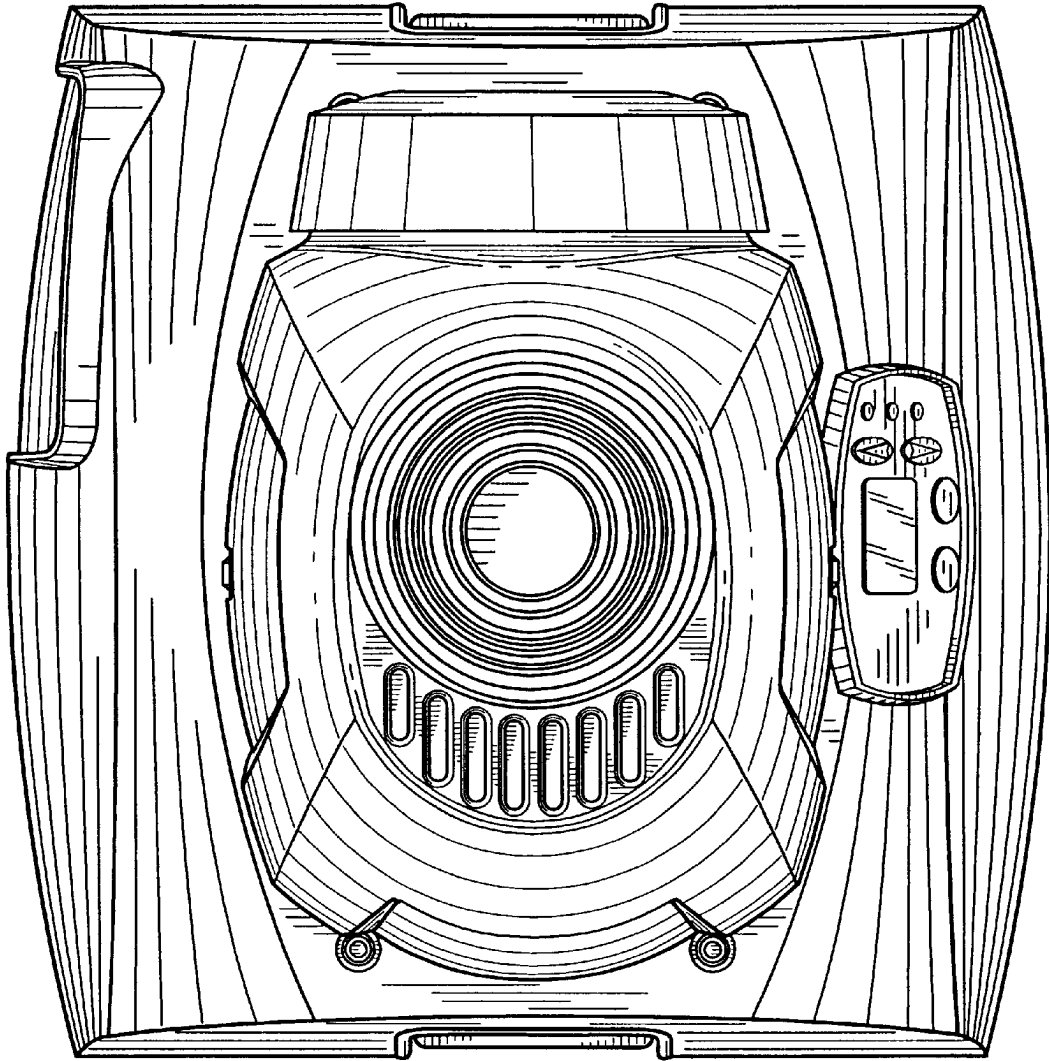

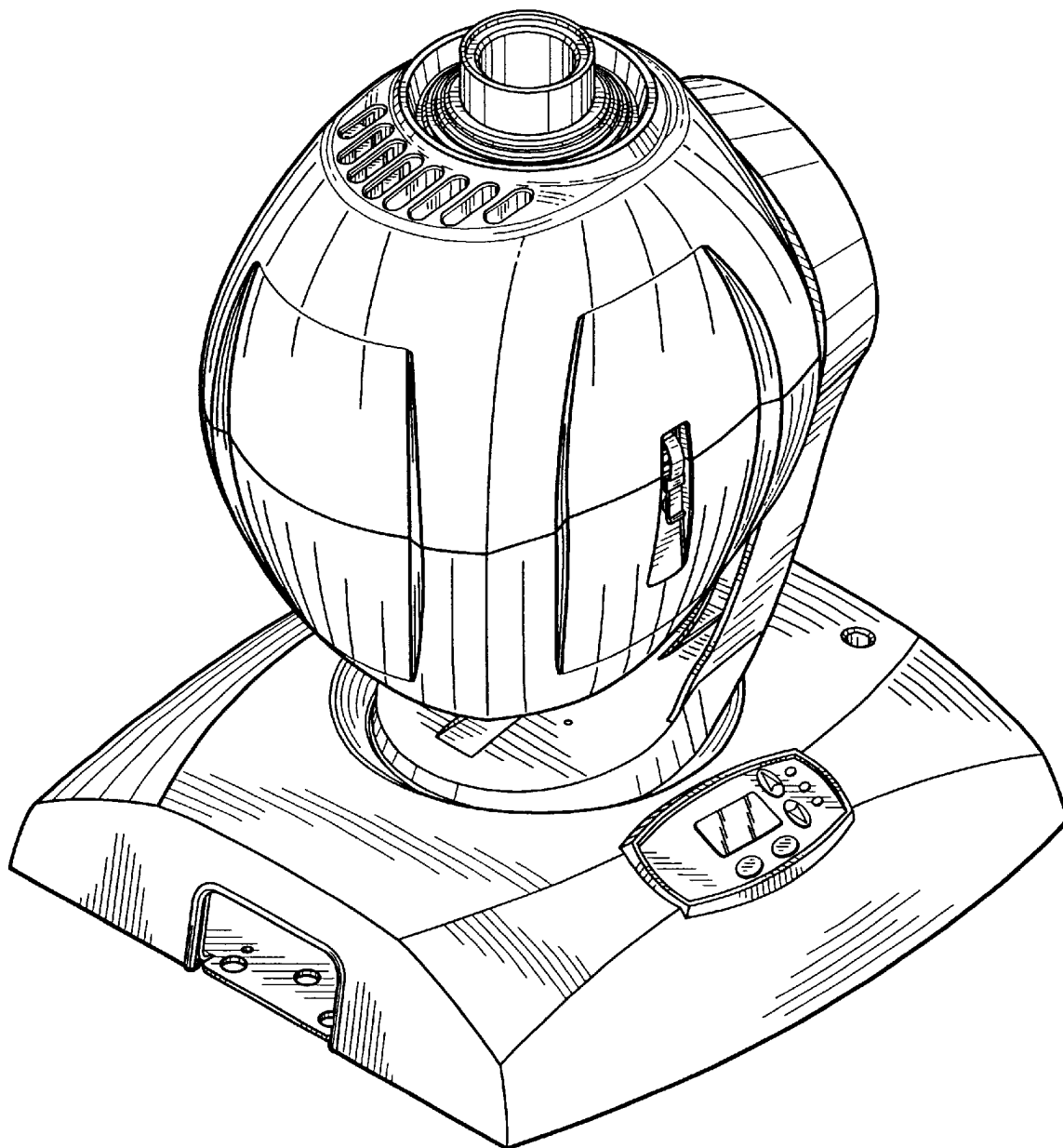
